TERMS & CONDITION

1. Last date of selling quotation Form will be 12.09.2018 upto 5 P.M. & Date of receiving Quotation is 14.09.2018 from 11.00 A.M. to 3.00 P.M. The same will be opened on the day if possible.
2. The Quotationer or his representative may remain present at the time of opening of quotation.
3. The rate should be quoted clearly in word & figure .The quoted rate shall be net & final inclusive of loading, unloading & transportation etc. Nothing extra shall be paid on this account.
4. The lowest quotationer has to supply flowering plants at different premier institution under Dy, Director of Horticulture, West District.
5. The planting materials should be healthy & free from all diseases, pest Infestation & injury.
6. Flowering Plants must be true to type according to their varietal character & size/ height as per specification.
7. Plant height to be considered excluding earthen tub/polybag size.
8. Payment will be made on the basis of performance of the Flowering Plants.
9. The Quotationer must indicate stock available with them for each of the Flowering Plants.
10. Each quotation must accompany earnest money for an amount of Rs.3,000/- (Rupees three thousand) only in the shape of "Deposit at call"/Demand Draft in favour of the Dy. Director of Horticulture(West).
11. After issue of supply order delivery should be made within stipulated period.
12. Supplied Flowering Plants may be rejected by the authority if found inferior.
13. The rate finalized will remain valid up to one year from the date of acceptance; if necessary it may be extended for another few months.
14. The provisional deduction of tax at source shall be at the rate as notified by the Government, from time to time.
15. **The Quotationer should submit ITC, PTC clearance certificate, GST registration, experience certificate on the subject at the time of quotation including Xerox copy of PAN Card and they should well experience on that line.**
16. **The plants in tubs/poly bags will be rejected if they are shifted recently (about 30 days) from the field.**
17. **The undersigned reserves the right to accept or reject any quotation including the lowest quotation without assigning any reason.**
