## MEMORANDUM

Subject: - General Election to the Autonomous District Council, 2021-Restrictions on fresh appointment /ad-hoc appointment/promotion/transfer and leave etc. with immediate effect in the Tripura Tribal Areas Autonomous District Council areas.

The office of the Election Commissioner for District Council, Tripura vide their letter No.2(37)-EC/DC/GEN-ELEC/2021/17525 dated 2<sup>nd</sup> March, 2021, has announced the General Election to the Autonomous District Council, 2021 which is scheduled to be held in the State of Tripura on 4<sup>th</sup> April, 2021.

- 2. In view of the ensuing General Election to the Autonomous District Council, 2021, the undersigned is directed to state that the following restrictions shall have immediate effect till the Election process is completed for smooth conduct of the said Election.
  - (i) No fresh appointment/ad-hoc appointment shall be made in any of the Government Department, Government Undertaking, Companies, Corporations or any other Autonomous Bodies under the State Government.
    - No transfer of officers or employees shall be made in any of the Departments or Institutions referred to in Para (i) above.
    - Leave should not normally be granted to any Government Officer/employee except on Medical Ground (to be certified by the State Government doctor) or in exceptional circumstances.

In case of officials drafted for Election duties, application even for Casual Leave will not be entertained unless it is necessary on Medical ground. In such exceptional cases, where leave is to be sanctioned, the sanctioning authority should inform the concerned Returning

- Officer in advance for sanction of leave or where not possible, simultaneously with such sanction.
- (iv) No officer/staff should be deputed for training except with the specific approval of the Chief Secretary.
- 3. These restrictions are applicable in the **Tripura Tribal Areas** Autonomous District Council areas.
- 4. All Departments/ Heads of Departments are requested to ensure strict compliance with the above restrictions.
