NOTIFICATION

In exercise of the powers conferred by the Section-135B of the Representation of the People Act, 1951, the Governor, Tripura is pleased to declare that all the Government Offices, Magisterial Courts, Educational Institutions, Financial Institutions and all other establishments shall remain closed **falling** within the jurisdiction where **General Election to Municipalities, 2021 is going to be held**, to enable the voters to exercise their right of franchise.

1. **The 25th November, 2021 (Thursday)** will also be a paid holiday for the employees of Industrial undertakings, all other establishments of Govt. of Tripura coming under the purview of the Factories Act, 1948 and daily rated/Contingent Employees under the Government of Tripura and workers/employees in any business/trade in Tripura posted under the jurisdiction where **General Election to Municipalities, 2021 is going to be held**, to enable them to exercise their right to franchise on the poll day.

2. There may be cases where a person is ordinarily a resident of the constituency and registered as an elector in the jurisdiction where **General Election to Municipalities, 2021 is going to be held** but serving/employed in Government Establishment or an industrial undertaking or other establishment located outside the said jurisdiction. In such cases, the electors are **allowed to avail Special Casual Leave to cast their vote**. Similarly, casual/daily wages workers working outside the constituency would be entitled to the benefit of a **paid holiday on 25.11.2021** under Section 135B(1) of the Representation of the People Act, 1951.

3. This shall not apply to any elector whose absence may cause danger or substantial loss in respect of the employment in which he/she is engaged.


