

Minutes of the 2nd meeting of the State Level Sanctioning Committee (SLSC) on Rashtriya Krishi Vikas Yojana (RKVY) for the year 2013-14, held on 24.2.2014 at 3.30 PM in the Conference Hall No: II, New Secretariat Building, Capital Complex, Agartala, Tripura.

The meeting was chaired by the Chief Secretary, Government of Tripura. The list of Officials present in the meeting is at Annexure: I

2. The Principal Secretary (Agriculture), Government of Tripura has welcomed all the participants in the meeting and made a presentation indicating status of utilization of RKVY funds, implementation of projects sanctioned during 2013-14.

3. Sri S.K.Singla, Director (Horticulture), Ministry of Agriculture, Department of Agriculture and Cooperation, Government of India, Sri Manas Choudhury, Dy. Advisor (Agri), Planning Commission, Government of India and Sri D. Venkateswara Rao, Asstt. Commissioner (Fisheries), DAHD&F, Krishi Bhawan, Government of India were present in the Meeting.

4. Total allocation for the State during 2013-14 is under Stream: I of RKVY is Rs. 4510.00 lakh and under Sub-Scheme is Rs. 1415.00 lakh. Project approved by 1st SLSC held on 2.9.2013 for Rs. 4132.00 lakh and Rs. 615.00 lakhs respectively.

5. After detailed discussion, the following decisions have been taken:

I. Projects worth of Rs.378.00 Lakh have been approved from Stream: I fund under normal RKVY of 2013-14 against the remaining allocation of Rs. 378.00 lakhs.




