### Notice Inviting Tender

Tender in sealed cover is hereby invited by the Joint Director of Agriculture ( Res. ), State Agriculture Research Station, Arundhatinagar, Tripura, Pin-799003 on behalf of the Governor of Tripura from the bonafied, recognized, registered, resourceful and experienced printers who are also experienced in printing of polythene packets etc. for supply of printed polythene packets which to be used in the State Bio-Control Laboratory, State Agri Research Station, Arundhatinagar, Agartala, Tripura.


The Tenderers are to be responded as per terms & conditions & specification of the items appended herewith (Annexure – I).

### Terms & Conditions

- 1) All the tenders are to be submitted with in stipulated date and must be super scribed on envelope / cover as “**Tender for supply of Printed Polythene Packets for State Bio-Control Laboratory**”.
- 2) Tender will be received **up to 3 p.m.** on 28<sup>th</sup> May, 2018 on sealed cover and shall be addressed to the Joint Director of Agriculture ( Res.), State Agriculture Research Station, Arundhatinagar, Agartala, Pin - 799003, Tripura and will be opened on the same day at 4. p.m. if possible. The tenderer or their authorized representative may also remain present at the time of opening of the tender.
- 3) The rate shall be quoted clearly both in figures and words as per specification against each item.
- 4) Rate shall be quoted inclusive of all taxes.
- 5) **Technical Bid** and **Price Bid** are to be submitted separately in sealed cover.  
Sealed envelope for “**Technical Bid**” should contain :
  - a) Earnest Money Deposit in appropriate shape.
  - b) Complete specifications of the material offered.
  - c) Excise registration details.
  - d) GST registration number and certificate.
  - e) Photocopy of PAN card.
  - f) All other documents, except price bid or rate quotation related papers, shall be in the envelope of “**Technical Bid**”.


**Price Bid :**

- The second sealed envelope should contain only price bid. The envelope should be clearly marked " **Price Bid** " and also indicating Tender No. and Due Date. Both the envelopes as above should be put into an outer envelope and duly sealed and should be properly super scribed with the Tender No. and Due Date.
- 6) The supply should be completed with in 15 (fifteen) days from the date of receipt of supply order.
  - 7) Over writing or use of correction fluid shall invite cancellation of tender papers..
  - 8) Earnest money of Rs. 5000/- (Rupees Five thousand) only shall be deposited in the shape of "Deposit at call" on any Nationalised Bank and be placed in favour of Joint Director of Agriculture ( Res. ) , State Agri Research Station, Arundhatinagar, Agartala, along with the tender without which the tender will not be treated as valid.
  - 9) Each of the Tenderer shall have to submit up-to date professional tax clearance certificate along with their tender, without which tender will be treated as invalid one.
  - 10) The earnest money of successful Tenderer who will refuse to undertake the work shall be forfeited to the Govt.
  - 11) The quantity as mentioned may increase or decrease as per requirement after finalization of the tender / rate etc.
  - 12) The undersigned reserves the right to accept or reject tender in part or full without assigning any reason thereof.
  - 13) The detail Technical specification of the materials is given in detail at Annexure-1
  - 14) The rate shall be valid up to 30. 04. 2019.


