The contractor should not be permitted for works in this Division (responsible for award any execution of contract in which near relative is posted as Divisional Accountant/ as an officer in any capacity between the grades of Superintending Engineer and Assistant Engineer (both inclusive). He shall also intimate the name of persons who are working with him in any capacity or are subsequently employed by him and who are near relatives of any Gezetted Officer in the Division. Any breach of this condition by the contractors would render him liable for removal from the approved like of contractors of this Department.

6. No engineer of Gezetted rank or other Gazetted Officer employed in Engineering or Administrative duties main Engineering Department of the Govt. of Tripura shall be allowed to work as contractor for period of two years of his retirement from Govt. services without the prior permission of the Govt. of Tripura. The contract is liable to be cancelled if either the contractor or any of his employees is found at any time to be such a person who had not obtained the permission Government of Tripura as aforesaid, before submission of the tender or engagement of workers inn the contractor's services, as case may be.

7. a) Tender form will be sold on submission of documentary proof of tenderer's Nationality, PTCC, PAN CARD issued by the Income Tax Department, Govt. of India, Enlistment/Registration and valid license regarding engagement of workers in the contract work from the Labour Department, Govt. of Tripura, Experience Certificate in respect of successful completion of similar nature of work. Tenders, which are not in prescribed printed form and are not purchased from office of the Executive Engineer (South), Udaipur, Gomati/ the Assistant Engineer(Mech), Bagafa Agri. Engg. In case of farms and companies tendering for then works, those farms and companies shall be registered in India. 8. a) The contractor (s) shall quote the rates and amount tender by them both in figures as well as in words. The amount for each item shall be worked out and requisite total shall be given. When a contractor signs a tender in Indian language the rate and amount shall also be written in that language. In such cases, the rate and amounts tendered shall be attested by the witness.

b) Special care should be taken so that the rates and amount are always written both in figures and in words in such a way that interpolation is not possible. In case of figure, the words Rs should be written before the figure and paisa at the end (viz. 250.00p;). In case of rate or amount in words Rupees should precede and the word only shall be written at the end (viz Rupees two hundred fifty and paisa only).

c) Item(s) for which no rate or price has been entered by the contractor /Agency shall not be paid for and shall be deemed covered by other rates/prices in contract.

d) When there is a difference between the rates in figures and in words, the rates, which correspond to the amount worked out by the contractor shall be taken as correct.

e) When the amount of an item is not worked out by the contractors or it does not correspond with the rates written either in figures or in words, the the rate quoted by the contractor shall be taken as correct.

f) When the rate quoted by the contractor in figures and words tallies but the amount is not worked out correctly the rate quoted by the contractors hall be taken as correct and not the amount.

g) All correction of rates and amount in the tender shall be initialed by the contractor, livery page including the blank pages shall be signed by the contractor.

h) In case of percentage rate tender, the contractor are required to quote their rates both in amount as well as in the percentage below/above the rates entered in the schedule. In case in the event of arithmetical error committed in working out the amount by the contractor, the tendered percentage and not the amount should be taken in to account.

- 14. The authority reserved the right to declare the bidding process as cancelled, at any time without any reason thereof.
- 15. Tenders which do not fulfilled any of these conditions or are not complete in any respect, may be liable for summery rejection.

- 18. The whole work may be split up between two or more contractors or accepted in part and not in entirely, if considered expedient.
- 19. The contractor's responsibility for this contract shall commence from the date of issue of acceptance order of tender.
- 20. Letters etc. found in the tender bc for raising or lowering the quoted rates or dealing with any other point in connection with the tender shall not be considered.
- 21. Sales Tax/VAT/GST, any other tax, duties, royalties etc on materials and works in respect of this contract shall be payable by the contractor and government will not be entertain any claim what so ever in this respect.
- 22. In case the contractors failed to commence the work specified in the tender document in 15th day or such time period as mentioned in letter of award after the date on which the engineer-in-charge issued written order to commence the work or from the date of handing over the site which ever is later the govt shall without prejudice to any other right or remedy, be at liberty to forfeit whole of the earnest money absolutely.
- 23. All work shall be carried out in accordance with the Tripura PWD specification and where Tripura PWD specification is silent specification of CPWD/CPHEEO/MORT & H/HIS, or if any specified separately will be followed.
- 24. All tools, plant and implements required for the construction of the work except those mentioned to be supplied by the department on hire charges will have to be arranged by the contractor at his own cost.
- 25. No labour under 14 years of age shall be employed in the work and all laborers employed shall be paid at the rates not less than those approved by Govt. of Tripura. Fair wage clause and relevant order of the government of Tripura will be binding on the contractor.
- 26. No claim for idle laborers and establishment will be allowed on account of delay in supply of departmental tools, plants and materials.
- 27. Contractor shall be responsible for shortage or wastage of departmental materials if issued to the contractors.
- 28. Recovery or surplus quantity of materials issued but not returned shall be made from the contractor's bill at double the issue rate of materials.
- 29. No transfer or earnest money from any amount already at the credit of tenderer's (as earnest money or security deposit in correction with the other works) will not be allowed.
- 30. Contractors are to arrange all materials for work including stipulated materials, if not available in the store at any time. However, no difference of cost between the market rate & issue rate will be allowed.

ARBITRATION AND LITIGATIONS CASES

1. SETTLEMENT OF DISPUTES :-

a. If a dispute difference of any kind whatsoever arises between the Department and the contractor in connection with or arising out of the contractor, whether during the progress of the works or after their completion and whether before or after the termination abandonment or breach of the contract, it shall in the first place, referred to an settled by the Engineer-In-Charge who shall, within a period of thirty days after being requested by the contractor to do so, give written notice of the decision of the contractor. Upon receipt of the written notice of the decision of the Engineer-In-Charge the contractor shall promptly proceed without delay to comply with such notice of decision.

b. If the Engineer-In-Charge fails to give notice of as decision in writing within a period of thirty days after being requested or if the contractor is dissatisfied with the notice of the decision of the Engineer-In-Charge, the contractor may within thirty days after receiving the notice of decision appeal to the Department who shall offer an opportunity to the contractor to be heard and to offer evidence in support of his appeal, subject to arbitration, as hereinafter provide. Such decision of the Department in respect of every matter so referred shall be final and blinding upon the contractor and shall forthwith be given effect to by the contractor, who shall proceed with the execution of the work with all due diligence whether he requires arbitration as hereinafter provide or not. If the Department has been communicated to his by the contractor within a period of thirty days after being requested as a aforesaid, or if the contractor be dissatisfied with any such decision, then and in any such case the contractor within thirty days after expiration of the first named period of thirty days as the case may be required that the matter or matters in dispute be referred to arbitration as detailed below :
