

## NOTIFICATION

**Subject:** <u>Mukhyamantri Pratibhashali Puraskar Scheme- Incentive Scheme for</u> <u>outstanding performance in sports at National and International levels.</u>

## 1. Introduction:

It has been decided to introduce the Mukhyamantri Pratibhashali Puraskar Scheme to provide financial incentive to outstanding sportspersons in different disciplines of games & sports with an aim to encouraging excellence in performance at National and International levels.

## 2. Objective:

- i. To encourage participation in games and sports in the State.
- ii. To improve the standard of performance of sportspersons in the State and to motivate them to attain excellence in performance at National/International level competitions.

# 3. Eligibility Criterion:

Bona fide sportspersons and teams, domicile of origin in the State of Tripura, who have represented the State/Country at National and International competitions in the disciplines of games and sports recognized by the Indian Olympic Association (IOA) will be considered. In case of School Level Games, only events/games recognised by School Games Federation of India (SGFI) will be considered under the scheme. ii. Cash incentives for individual events in National level competitions shall be as follows:-

- v. Cash Awards for team events: For team events, the incentive will be 50% of the of the corresponding individual event award multiplied by the number of team members, including admissible reserves.
- vi. The quantum of cash award to be given to qualifiers for the Olympic Games shall be decided by the Committee constituted in para 5.
- . vii. The quantum of cash award can be increased or decreased as per recommendation of the Committee constituted in para 5.
  - viii. Coaches with outstanding achievements at National/International competitions will also be considered for some form of award under the scheme, the quantum of which shall be decided by the Committee formed at para 5.

- ix. The Mukhyamantri Pratibhashali Puraskar so constituted will be considered for the performance in those sports competitions which will be held from the beginning of the financial year 2019-20.
- x. A sportsperson will be eligible to receive only one award in a financial year irrespective of the number of medals he/she had won during the year. In such cases, the highest achievement of the concerned sportsperson shall be taken into account and the incentive will be given to him/her accordingly.
- xi. The Mukhyamantri Pratibhashali Puraskar shall be awarded once a year to sportspersons who have won medals in the identified competitions that year.

#### 5. Selection Process and Selection Committee:

- i. Eligible applicants (sportspersons) may apply in plain paper to the Youth Affairs & Sports Department for receiving financial incentive under the scheme.
- ii. A 3(three) member committee, with the following officials shall assess the performance of sportspersons for the purpose of grant of incentives and submit it's recommendations to the State Government for further action:
  - a) Director, Youth Affairs & Sportsb) General Secretary, Tripura School Sports Boardc) Representative of Sports Authority of IndiaMember
  - d) Deputy Director, Youth Affairs & Sports- Convenor

#### 6. Savings:

In case of any disputes, the matter will be referred to the Youth Affairs & Sports Department, Government of Tripura and the decision taken by the Department shall be final and binding on all concerned.
