NOTIFICATION

The Governor of Tripura is pleased to order that accumulation at the credit of subscribers to the General Provident Fund (GPF) and other similar funds shall carry interest at the rate prescribed by Government of India from time to time.

Resolution of Government of India, Ministry of Finance, Department of Economic Affairs vide Nos. F. No.5(4)-B(PD)/2021 dated 19<sup>th</sup> April, 2021, 5<sup>th</sup> July, 2021, 5<sup>th</sup> October, 2021 and 3<sup>rd</sup> January, 2022 in this respect shall be deemed to be applicable on General Provident Fund and other similar funds of Government of Tripura for the financial year 2021-22.

For the present these funds shall carry interest at the rate of the following ;

- a) F. No.5(4)-B(PD)/2021 dated 19<sup>th</sup> April, 2021, interest rate will carry @ 7.1% (Seven point one percent) w.e.f. 1<sup>st</sup> April, 2021 to 30<sup>th</sup> June, 2021. This rate will be in force from 1<sup>st</sup> April, 2021.
- b) F. No.5(4)-B(PD)/2021 dated 5<sup>th</sup> July 2021, interest rate will carry @ 7.1% (Seven point one percent) w.e.f. 1<sup>st</sup> July, 2021 to 30<sup>th</sup> September, 2021. This rate will be in force w.e.f 1<sup>st</sup> July, 2021.
- c) F. No.5(4)-B(PD)/2021 dated 5<sup>th</sup> October, 2021, interest rate will carry @ 7.1% (Seven point one percent) w.e.f. 1<sup>st</sup> October, 2021 to 31<sup>st</sup> December, 2021. This rate will be in force w.e.f 1<sup>st</sup> October, 2021.
- d) F. No.5(4)-B(PD)/2021 dated 3<sup>rd</sup> January, 2022, interest rate will carry @ 7.1% (Seven point one percent) w.e.f. 1<sup>st</sup> January, 2022 to 31<sup>st</sup> March, 2022. This rate will be in force w.e.f. 1<sup>st</sup> January, 2022.
