TERMS AND CONDITION

- 1. Rate should be offered for Fertilizer, Seeds & P.P.Cs are to be per quintal in figure and words in each item from the supply point as mentioned above including loading and un-loading charges. Any overwriting in rate and conditional tender will not be entertained.
- 2. Rate will effect after approval of the Director of Agriculture, Government of Tripura and will remain valid up to 31/03/2019 which may be extended for more 3 (three) months i.e. up to 30/06/2019 if required.
- 3. Transportation of Seeds, Fertilizers & PPCs etc. are up to destination points delivery should be completed within 12 hours from the time of loading.
- 4. Adequate vehicles for transportation should be placed at loading point within 12 hours on receipt of such intimation. In case of delay in placement of vehicles resulting payment of demurrage involved will have to be borne by the contractor.
- 5. The value of quantity found short at delivery point including value of container if any will be recovered from the contractor at full cost.
- 6. All precautionary measures should be taken by the contractor, so that the inputs may not get wet or damage at the time of loading / un-loading and transit.

- 7. The contractor will be responsible for any damage / loss in quantity of materials due to handling or any other reason whatever during loading / un-loading or at transit period. In case of damage / deterioration on the quantity of materials, the value of the same shall be recovered from transport contractor at full cost.
- 8. Use of hook at any time of loading / un-loading is strictly prohibited.
- 9. Each tender should accompany with an earnest money @ 1% of the estimated cost amounting to Rs. 9,000/- (Rupees Nine Thousand) only in the shape of "Deposit at Call" in any scheduled bank pledged in favour of the undersigned. Up to date P.T.C. and I.T.C., Attested copy of registration of own vehicle and attested copy of Nationality Certificate should be submitted along with the tender.
- 10. In case of any parties who have been exempted by the Government from deposit earnest money photostate copy of Government order to the effect should be enclosed with the tender, otherwise the tender will not be entertained.
- 11. Approximate yearly turnover money involve near about 9,00,000/- (Rupees Nine Lakhs).
- 12. In the event of acceptance security money @ 10% of the estimated cost to the extent of Rs. 90,000/(Rupees Ninety thousand) only should be deposited by the successful tendered pledged in favour of
 the undersigned in the shape of "Deposit at Call" in any scheduled Bank within 7 (seven) days from
 the date of communication of rate approval and also execute agreement within the same period.
 The successful tenderer who fail to deposit security money and to execute Deed of Agreement, his
 earnest money will be forfeited to the Government.
- 13. In the event of failure transport from prescribed place to the destination within stipulated period the undersigned shall have to right to get the work done engaging any other Agency.
- 14. The carrying of Agri. Inputs will be done engaging carrying contractor as well as by the Department vehicle of any quantity of Agri. Inputs based on necessity.
- 15. The earnest money of the un-successful tenderer will be refunded after acceptance of rate.
- 16. The bill of cost in triplicate for carrying charges of Agri. Inputs should be submitted by 1st week of month following the month in which work was executed. The bill should not be accumulated. Payment will be made on actual gross weight of the container at delivered at destination point and on availability of fund.
- 17. Brief statement indicating the previous experiences of the tenderer in transport and handling of such items should be furnished along with tender.
- 18. In case of any dispute, decision of the Director of Agriculture, Government of Tripura shall be final & binding of the contract, The tender will be received by the undersigned on 11/05/2018 up to 3-00 P.M. and will be opened on the same date at 4-00 P.M. if possible. The tenderer or their authorized representative may remain present at the time of opening of the tender.
- 19. The undersigned reserved the right to accept or reject any tender partly or wholly including the lowest one without assigning any reason.
- 20. No. any other material should be transported along with the Agri. Inputs in the same vehicle which may cause damage of Agri. Inputs and other materials of the Department.
- 21. The selected tenderer shall have to execute a "DEED OF AGREEMENT" within 7 (seven) days on receipt of the communication of the acceptance of the tender for satisfactory performance of the job. The selected tenderer shall be bound to supply 4(four) copies of agreement one copy should be typed on non-judicial stamp worth Rs. 5/- only and the other 3(three) copies on semi paper. Within the contracted period any dis-satisfactory performance from the part of the Contractor, security money so deposited is liable to be forfeited in the event of failure to execute the work as per terms and condition of N.I.T.
- 22. The bill of cost in triplicate for carrying of Agri. Inputs should be submitted by the contractor along with duplicate copy of challan and payment will be made in actual gross weight basis and availability of fund under L.O.C. system. The Department shall not be liable for payment of any interest on any bill outstanding for payment.
- 23. Due to unavoidable circumstances, occurred on stipulated date i.e. on 11th May 2018 dropping of tender / tender will be received next working day.
- 24. A deduction of 2% (Two percent) or as admissible from each bill will be made as Income Tax plus admissible surcharge on such tax as per decision of the Government of India / Government of Tripura.
- 25. Seed should not be carried along with Fertilizer.
