**NOTICE INVITING TENDER FOR SUPPLY OF BANANA (Var. SABRI) AND PINEAPPLE (Var. QUEEN) SUCKERS FOR PLANTATION UNDER MGNREGA SCHEME DURING THE YEAR 2018-19 UNDER HEZAMARA AGRI. SUB-DIVISION**

Tender in sealed cover superscribed as “Tender for supply of Banana (Var. Sabri) and Pineapple (Var. Queen) for carrying out plantation programme under MGNREGA scheme during 2018-19 under Hezamara Agri. Sub-Division” are invited for and on behalf of the Governor of Tripura from the reliable and resourceful Supplier/Lamps/Co-Operative/Contractors of Indian National having financial stability for supply of planting materials for implementation of MGNREGA scheme during the year 2018-19.

The tenderer should quote the rates both in figures and words in the prescribed format, which is available in the office of the undersigned on any working day during the office hours upto 48 hrs before the scheduled time of dropping of the tender.

The sealed tender will be received in tender box in the office of the undersigned upto 3:00 PM on 30/07/2018 & will be opened on the same day at 3:30 PM, if possible in the office of the undersigned in presence of the tenderers or his/her authorized representatives.

**TERMS AND CONDITIONS**

1. Rates should be quoted per unit of sucker for both Banana & Pineapple in figures and words separately for each item indicated in the tender notice inclusive of expenses for loading/unloading etc. at supply point including stacking at the delivery points. There should be no over writing on the tender copy. Conditional tender whom amounts to the deviation of the terms & condition contained in the tender notice will not be entertained.
2. Rate should not exceed Rs. 15/- (Rupees fifteen) only and Rs. 2/- (Rupees two) only in case of Banana and Pineapple respectively at any cost.
3. The rate will remain valid for the financial year 2018-19 if approved by the Government and may be extended or curtailed if necessary.
4. In case of Banana suckers it should be of Sword Suckers having 3-5 leaves with healthy roots & Water Suckers will not accepted as planting materials.
5. In case of pineapple it should be of Side Suckers having 7-10 leaves with healthy roots and free from disease & all kind of debris. Lower quality suckers will not be accepted.
6. Mixing of other variety suckers with Sabri variety will not be allowed and if found guilty of mixing after supply at destination point, the same quantity of materials will be rejected after identification and fresh supply should be made by the supplier for free after getting intimation from the undersigned and no extra bill can be claimed for the purpose.
7. An expert team/committee will be formed at sub-divisional level and they will check the quality of planting materials regularly and certify thereafter on satisfaction, depending on which the bill for planting materials will be settled.
8. Supply of planting materials up to the destination point of delivery should be completed within 24 hours positively from the time of loading at source.
9. Required planting materials in good health condition should be supplied immediately on receipt of supply order / intimation. In case of delay in supply by the first party, the second lowest tenderer may be called for supply of the same and the first lowest tenderer will not be allowed to supply further.
10. No damaged or diseased planting materials or shortage of any will be accepted and the tenderer should be careful in this regard.



11. The value of quantity found short at delivery point, if any will be recovered from the supplier and payment will be stopped unless recover the shortage materials.
12. All precautionary measures should be taken at the cost of supplier so that the planting materials may not get damaged or dried in any way during loading, unloading & transit.
13. In case no staff available at delivery point to receive the materials, it should be informed to the undersigned or In-Charge HQ Store, Hezamara immediately for making alternative arrangement to receive the materials, but in no case the materials should be returned back to supply point.
14. All necessary valid documents like Nationality certificate, Adhaar card, Bank A/C photocopy, PAN card, Professional Tax clearance certificate, GST registration certificate and any other essential documents to be enclosed alongwith the tender, failing which the tender will not be entertained.
15. Each Tender should accompany with Earnest Money of **Rs. 20,000/-** (Rupees Twenty Thousand) only in the shape of "Deposit at Call" from any Nationalized/Govt. undertaking Bank pledged in favour of the **Supdt. of Agriculture, Hezamara** without which the tender will not be entertained.
16. The Earnest money of the unsuccessful tenderers shall be refunded after the acceptance of rate. The Earnest money of the successful tenderer (s) shall be treated as security money which will be kept in the o/o the undersigned.
17. In case the security deposit and any other money due to the supplier from the Government does not suffice to meet up such expenditure, the Government will have the right to recover the amount of such expenditure from the supplier by other suitable means.
18. The bill of cost in triplicate for planting materials should be submitted immediately after supply of the materials. Payment will be made on actual number of the materials delivered at destination and subject to availability of fund or any other restriction imposed by the Government from time to time.
19. A brief statement indicating the previous experience if any of the tenderer (s) for supply of planting materials like banana & pineapple should also be furnished alongwith the tender. Deed of lease or any other paper in this respect will not be entertained.
20. The undersigned reserves the right to accept or reject or cancel the tender fully or partly including the lowest one without assigning any reason & also reserves the right to distribute the works to more than one supplier, if considered necessary.
21. In case of any disputes, the decision of the Director of Agriculture, Government of Tripura shall be final & binding on the supplier.
