## TERMS AND CONDITIONS OF CONTRACT:

- 01) Each tender should accompany with earnest money of the Rs.70, 000/-(Rupees Seventy thousand) only in the shape of Deposit at call on any scheduled Bank pledged in favour of the undersigned. In any circumstances without earnest money tender will not be accepted.
- 02) Place for dropping tender is at the, office of the Deputy Director of Agriculture, West Tripura, A.D.Nagar Agartala on 17/07/2018.
- 03) There should not be any over writing.
- 04) Tender may be submitted either personally or by registered post within the scheduled time and date. No tender will be entertained after the above stipulated time and date.
- 05) The undersigned shall not be liable for non delivery of the tender by the postal authority within the scheduled time and date.
- 06) Rate should be quoted per unit i.e per quintal. Rate should be quoted both in figures and in words for each supply point to delivery point separately for each of commodities indicated in the tender notice which should include the expenses for weight man, stocking, stitching, loading and other incidental charges at the supply

point and also include the expenses for unloading weight man, stocking and any other incidental charges at delivery point.

- 07) Rates will remain valid up to 30<sup>th</sup> SEPTEMBER 2019.
- 08) Transportation of materials up to destination point and delivery should be completed positively within 24 hours from the time of loading.
- 09) Adequate vehicles for transportation should be placed at loading point within 24 hours on receipt of such intimation, in case of delay in placement of vehicles, transportation will be done by hiring vehicles of other person on negotiation basis and excess amount if any required for such carrying shall have to be borne by the carrying contractor of the excess amount which will be deducted from his bill as the case may be.
- 10) Tendered must quote rate for all mentioned destination points.
- 11) No transportation shortage will be allowed under any circumstances.
- 12) The value of the quantity found short at delivery point including value of container, if any will be recovered from the transport contractor the rate which may be fixed by the Director of Agriculture, Tripura and such quantity will be treated as not carried and carrying cost of the said quantity cannot claimed / will not be paid.
- 13) All precautionary measures should be taken at the cost of the contractor that the Agri inputs may not get damaged in any way during the loading, unloading and transit.
- 14) The contractor shall be responsible for any damage of deterioration in the quantity of the materials due to mishandling or any other reasons what so ever during loading / unloading and transit period, in case of damage, deterioration of the quantity, loss of the materials, the value of the same shall be recovered from the transport contractor at the rate fixed by the Director of Agriculture, Tripura and no carrying cost for said quantity shall be claimed and paid to contractor.
- 15) No other materials should be transported along with the Agri inputs in the same vehicle which may cause damage to Agri inputs and other materials of the department.
- 16) Up-to-date professional tax clearance certificate, GST Registration Certificate, up-to-date income tax return (F/Y 2017-18) and attested copy of nationality certificate should also be enclosed along with tender failing which no tender will be entertained.
- An experience certificate in respect of surface carrying should be submitted along with the tenderer.
- 18) In case of any party claims to have been exempted by the Government from depositing security money/ income tax return. in order to that necessary supporting documents should be enclosed with the tender; otherwise the tender will not be entertained and treated as invalid.

Security money to the extent of Rs.7,00,000/- (Rupees Seven Lakh) only should be deposited by successful tenderer placed in favour of the undersigned in the shape of "Deposit at call" on any schedule Bank within 3(three) days from the date of communication of rate approval and also execute "Deed of Agreement" within the same period for satisfactory performance of the contractor. Earnest money of the successful tender, if he fails to deposit security money and execute "Deed of Agreement" within the time mentioned above shall be forfeited to the Government. The earnest money of the unsuccessful tenderer shall be refunded after the acceptance of the rate. The earnest money of the successful tenderer may be treated as part of security money if any written request received from the tenderer. Rest money as security money to be deposited by the successful tenderer before execution of work.

20) In case of failure to transport from the prescribed points to the destination points within stipulated period the undersigned shall have the right to get the work done through any other agency / party and the extra expenditure including payment of damage, if any involved in such event shall have to be borne by the contractor. In case the money as security deposit and any other money due to the contractor from the Government does not suffice to meet up such expenditure the Government will have the right to recover the amount of such expenditure from the contractor by order or suitable means.

21) The carrying contractor will have to carry as and when required to cope up with the urgency of transportation of Agri inputs where he can not object to carry Agri inputs and other related materials.

- 22) The bill towards the cost for carrying of Agri Inputs in triplicate dully certified by the concerned main store in-charge and countersigned by the concerned Supdt. of Agriculture of the respective Agri sub-division should be submitted by the 1<sup>st</sup> week of the month following the month of which work was executed. Payment will be made on actual basis not weight basis of the materials i.e. actual weight of materials excluding the weight of container to the destination point as per availability of fund.
- 23) In case of any dispute the decision of the Director of Agriculture, Tripura shall be final.
- 24) A brief statement indicating number of vehicles owned by the tenderer with registration numbers (at least three vehicles) should be furnished along with the tender.
- 25) The Director of Agriculture, Tripura reserves the right to accept or reject any of the tender / tenderer or part there-of including the lowest one without assigning any reason and also reserves the right to distribute the work to more than one contractor if considered necessary.
- 26) The rate may be remained valid upto 3 (three) months after expiry of validity of approved rate.
