**NOTICE INVITING TENDER FOR CARRYING OF AGRI INPUTS UNDER
KILLA AGRI. SUB-DIVISION FOR THE YEAR 2019-20.**

Tender in sealed cover subscribed as "Tender for carrying of Agri. Inputs in Killa Agri. Sub-Division" is hereby invited on behalf the Governor of Tripura from the bonafide and resourceful transport contractors of Indian Nationals having financial stability for carrying of fertilizer / seeds / P. P. Chemicals/ other Agri. Inputs. etc as mentioned below. The tenderers should quote their rates both in figure and words in Plain papers.

TERMS & CONDITIONS OF CONTRACT


1. Rate should be quoted per unit both in figures & words for each supply point to delivery point separately for each commodity indicated in the tender notice inclusive of expenses of loading / Weightment at supply point / unloading with Weightment including stacking at the delivery points. There should be no overwriting. Conditional tender which amounts to the deviation of the terms & conditions contained in the tender notice will not be entertained.
2. Rate should be quoted per Quintal for each destination Point.
3. Rate will remain valid up to next 1 year & may be extended by another 3 (Three) months, if necessary.
4. Transport of materials up to the destination point of delivery should be completed within 24 hours positively from the time of loading.



5. Adequate vehicles for transportation should be placed at loading points within 24 hours on receipt of such intimation. In case of delay in placement of vehicles resulting payment of demarage if any involved will have to be borne by the Contractor.
6. No transport shortage will be allowed under any circumstances.
7. The value of the quantity found short at delivery point including value of container if any will be recovered from the transport contractor at rate which may be fixed by the Director of Agriculture, Govt. of Tripura & such quantities will be treated as not carried & carrying cost for the same quantity cannot be claimed.
8. All precautionary measures should be taken at the cost of the contractor so that the Agri. Inputs etc. may not get wet or damaged in any way during loading, unloading & transit.
9. The Contractor shall be held responsible for any damage or loss or deterioration in the quantity of the materials due to mishandling or any other reasons what so ever during loading, unloading & transit period. In case of damage / deterioration in the quality of the materials the value of the same shall be recovered from the transport contractor at rate fixed by the Director of Agriculture, Govt. of Tripura & no carrying cost for said quantity shall be claimed & paid to the contractor.
10. Use of hook at the time of loading or unloading or during transit is strictly prohibited.
11. No other materials should be transported along with the Agri. Inputs in the same vehicle which may cause damage of Agri. Inputs & other materials of the Department.
12. Each tender should accompany earnest money for an amount of Rs.2500/- (Rupees Two thousand five hundred) only in the shape of "Deposit at Call" of any scheduled Bank pledged in favour of the undersigned. Up to date attested copies of Income Tax Clearance Certificate, Professional Tax Clearance Certificate, PAN Card, valid contract labour license issued by Licensing authority & attested copy of Nationality Certificate should also be enclosed along with the tender, failing which no tender will be entertained.
13. The earnest money of the unsuccessful tenderers shall be refunded after the acceptance of rate approval from the Department. If the successful tenderer surrender his/her quoted rate, the earnest money shall be forfeited to the Government.
14. The Successful tenderer should deposit @ 10% of total cost of tender as security money on any scheduled Bank pledged in favour of the undersigned within 7 days from the date of issue of rate acceptance. If the successful tenderer fails to deposit security money within the stipulated period, the tender should be treated as invalid and rejected deposited earnest money shall be forfeited to the Government.
15. Vehicle offer by the successful tenderer should have all up to date valid documents required by the transport Deptt. for running a vehicle on the road.
16. The yearly involvement of amount for the same purpose may be Rs. 2.50 lakh (Apx.).



17. In the event of failure to transport from the prescribed place to the destination within stipulated period, the office shall have right to get work done through any other Agency / Party & the extra expenditure including payment of demerge if any involved in such event shall have to be borne by the contractor. In case the security deposit & any other money due to the contractor from the Government does not suffice to meet up such expenditure, the Government will have the right to recover the amount of the such expenditure from the contractor by other suitable means.
18. The bill of cost in triplicate of carrying of Agri. Inputs should be submitted by the first week of the following month on which the work was executed. The bill should not be accumulated. Payment will be made on actual weight of the materials delivered at destination & subject to the availability of fund under L.O.C. system or any other restriction imposed by the Government from time to time. No interest should be claimed in case of delay in making payment. Income Tax & any other tax if any as applicable as per rules in force will be deducted from the bill.
19. A brief statement indicating the previous experience of the tenderer in transport & handling of store business & the number of vehicle owned by the tenderer indicating Registration number should be furnished along-with the tender. Loss of deed or any other papers in this respect will not be entertained.
20. In case of any dispute the decision of the Director of Agriculture, Government of Tripura shall be final regarding binding on the contractor.
21. The sealed tenders will be received in the office of the undersigned from **11.00 A.M. to 03.00 P.M. on 20-08-2019** & will be opened on the same day in the Office of the undersigned if possible, where the tenderer or his / her authorized representative may remain present.
22. The Supdt. of Agriculture, Killa reserves the right to accept or reject any or all the tenders fully or partly including the lowest one without assigning any reason & also reserves the right to distribute the work to more than one contractor, if considered necessary.


