- > Validity of registration of the Micro Irrigation System Manufacturers/ Suppliers shall remain valid for a period of 4(Four) years from the date of issue of this "NOTIFICATION" subject to satisfactory performance by the company.
- > Repeated failure of satisfactory performance will lead to de-registration of the company.
- > This Notification is issued in cancellation of this Department's earlier notification vide no. F.4(215)-AGRI/SARS/GEN/2021-22/2049-2123 dt. 15.06.21 in this regard.
- Manufacturing companies which have all the facilities to ensure supply of quality products as per BIS standards and can provide prompt after sale services are registered.
- > The company must provide guarantee of quality assurance of other components which are not manufactured by them in various technologies covered under the scheme.
- > The company must provide free after sale services to the farmers for 3 years from the date of installation of the systems in their field.
- > All the companies should have their local authorized dealers in the state.
- > Necessary orientation and training to be given to the beneficiaries on the system maintenance & irrigating the crop with sprinkler irrigation by the company.
- The beneficiaries shall be free to purchase MI equipment from any MI manufacturer out of the approved list of MI manufacturers and are free to negotiate with the rate quoted by the registered manufacturers.

- Selected Farmer/ Beneficiaries shall submit his/her preferred Brand/ Model from empanelled list including address where the selected item will be delivered in written form to the scheme implementing authority (The entrusted authority to disburse the subsidy amount).
 - Vender/ Empanelled Bidder/ Supplier have to sell the selected product to the selected farmer/ beneficiaries on receipt of confirmation of name with preferred brand / model on payment of farmer's contribution.
 - All Superintendent of Agriculture/ Superintendent of Horticulture/ Executive Engineer/ Officer of the Department shall act as the implementing authority for installation of these systems at farmer's field.
 - > The physical inspection after installation of the system, shall be conducted jointly by all the concerned officers including Agri. Sector Officer, Junior Engineer, Firm Representative and concerned farmer beneficiary before releasing the subsidy.
 - > The Govt. share (subsidy portion) will be released to the Vender/ Empanelled Bidder/ Supplier after successful implementation of the programme in farmer's field and presentation of bill in proper shape for claim in this regard.

TERMS AND CONDITIONS

- Government will not procure any Sprinkler (Portable/ Mini) Irrigation System through this empanelment process. This process is only for empanelment of Bidder/ Supplier for supply & installation of Portable and Mini Sprinkler Irrigation System.
- Farmers shall apply for desired sprinkler irrigation system to the nearby departmental institutions like Agri. Sector Office, Supdt. of Agriculture/ Horticulture office for availing the assistance under the scheme PMKSY (PDMC) indicating desired brand from the empanelled list, along with a) Detail personal information, b) Land details, c) Aadhar details, d) Bank details etc.
- 3. Financial assistance to each farmer is limited to maximum 5 ha, area and beneficiary once benefitted cannot avail scheme assistance for the next 7 years.
- 4. On receipt of application from the farmers, necessary initiative shall be taken by the concerned SA/SHs for completion of joint field verification with farm representative and preparation of estimate within 20 days of receipt of the application and sanction of work order.
- Desired Sprinkler Irrigation Systems is to be made available by the Vender/ Empanelled Bidder/ Supplier at specified location/ address of the farmer according to choice of Manufacturer, Brand Name & Specified Model.
- 6. Delivery shall be made in the prescribed period not exceeding 20 days from the date of intimation to the Vender/ Empanelled Bidder/ Supplier, failing which Vender/ Empanelled Bidder/ Supplier will be liable to de-list from the empanelment. Scheme implementation authority will bring the matter to the knowledge of the appropriate authority, Department of Agriculture, Government of Tripura.
- Government will disburse Financial Assistance amount as per "Operational Guidelines of PMKSY (PDMC)" for selected beneficiaries on procurement of their desired Sprinkler (Portable/ Mini) Irrigation System.
- Department may order for testing/ verification of the equipment before receipt/ delivery. The testing will be done at the cost of the supplier. The department may reject the offered goods/ equipments, if not found satisfactory in any manners as per test result.
- Vender/ Empanelled Bidder/ Supplier shall entirely be responsible for all G.S.T/ Taxes, license fees, transportation cost etc. incurred until delivery of the goods to the farmers.
- G.S.T will be deducted at source as applicable as per guideline at the time of release of subsidy amount.
- Venders have to sell the preferred machinery at farmer's doorstep on "Open delivery & demonstration basis".
- 12. Empanelled supplier must furnish progress report (Sale report) through e-mail, etc. to the appropriate Authority, Department of Agriculture & Farmers' Welfare, Government of Tripura, regularly in each month within 5th working day.
- 13. The pattern of assistance payable to the beneficiary under the micro irrigation scheme will be 55% for small and marginal farmers including Central and State Share. .

- 14. Beneficiary shall purchase Portable Sprinkler Irrigation System and Mini Sprinkler Irrigation System according to their choice of Brand with Financial Assistance from Govt. as per PMKSY norms.
 - 15. The Bidder / Supplying Company will provide free after sales service to the beneficiary for a period of at least 3 (three) years from the date of installation of the system as per PMKSY (PDMC) guidelines. If it fails to provide free after sales service, action as appropriate similar to other consumer products may be initiated.
