1. Rates are to be quoted both in figures as well as in words. Rates should be quoted Rs. Per kg.
2. Rs.3000/- (Rupees three thousand) only should be deposited as earnest money in the shape of deposit-at-call pledged in favour of the Joint Director of Agriculture(Research), SARS, A.D.Nagar, Aagartala. No EMI is to be desposted again those who participated in the same tender held on 12/10/2020
3. The EMD of the successful bidder will be kept as security deposit, which will be returned on completion of the Contract Term/Period whereas, for other bidders the same will be returned on completion of this tender process.
4. The total required quantity is estimated to be around 1,00,000 kg which may icrease or decrease as per actual field need. The suppliers should be capable to accomplish the supply of whole the quantity as per supply order within 15(fifteen) days from the date of issue of supply order.
5. In the event of failure to provide service or failing to comply with term & conditions etc. the contract will be cancelled, and any further action may be taken as deemed as per norms.
6. Well rotten condung will have to be supplied. The undersigned has the right to verify the supplied materials and may cancel the contract if found any lapses with regards to quality of supplied materials & non compliance to terms & conditions etc.

  - b) A photocopy of the citizenship/PRTC card as proof of Nationality or any photo ID of the tenderer.
  - c) The deposit-at -call for Rs.3000/- (Rupees Three thousand) only drawn as mentioned above.
  - d) PTC, clearance certificate by the competent authority to be enclosed along with the tender paper including photo copy of PAN card.
  - e) GST registration should be enclosed
  - f) Copy of PAN Card.

Once the rate is approved will remain valid for a period of 2(two) year from the date of acceptance and successful bidder will have to continue to serve for the period of supply and up to completion of the total supply, which may be extended.
