Sealed Quotation are invited, on behalf of the Governor of Tripura, from the Registered Farm / Nursery growers for supplying of dragon fruit seedlings (grafting) for implementation of different Govt. scheme under Supdt. of Agriculture, Kakraban Agri. Sub-Division, Kakraban, Udaipur Gomati Tripura for a period of 1 (one) year (w.e.f July 2020 to June 2021), which may also be extended for another 3 (Three) months, if required. Quotations will be received on 10th June 2020 from 11 A.M. up to 3.00 pm and will be opened on the same date in the office of undersigned at 4.00 pm, if possible.

The rate for supply of planting materials should be quoted in the following format both in figures and in words duly signed by the Quotationer. No over writing or erasing will be allowed / accepted.



B) TERMS & CONDITIONS:-

- 1. Quotations will be received on 10th June 2020 from 11 A.M. up to 3.00 pm and will be opened in the office of the undersigned on the same date at 4.00 pm, if possible.
- 2. The rates should be quoted both in figures and words clearly as asked in the above mentioned format, the quoted rate shall be net & final inclusive of loading-unloading & transportation. No extra shall be pain on this account.
- 3. Tender should be accepted only from Registered Farm/ Nursery. Registration of Nursery document shall be submitted.
- 4. Planting materials must be true to the type according to their varietals character size / height as per specification. Papers on varietal characters must be submitted along with this tender.
- 5. The planting materials should be healthy & fee from all diseases, pest infestation & injury.
- 6. Payment will be made on the basis of performance of the planting materials.
- 7. Planting materials will be inspected at Farm/Nursery before supply.
- 8. Quotioners shall have to deposit an earnest money to an amount of Rs. 1500/- per quotation in the shape of **D-call** in favour of Supdt. of Agriculture, Kakraban, Agri. Sub-Division, Udaipur, Gomati District, form any Nationalized Bank/Tripura Gramin Bank/Tripura State Co-Operative Bank and shall be submitted along with the sealed quotation. The said earnest money will be converted to Security money for successful bidder who would be offered the work. For others, the earnest money would be refunded. Earnest money will be forfeited if the owner fails to supply the planting materials within stipulated period.
- 9. No Quotation will be entertained without earnest money.
- 10. Quotationers or their representatives may remain present at the time of opening of tenders.
