1. The Participants shall submit in **TWO PART SYSTEM** i.e. **Technical Bid** and **Financial Bid** separately in sealed covers superscripted as **Technical Bid** and **Financial Bid** clearly on the top of the each sealed covers both Technical Bid and Financial Bid labeled with offer for **D.N.I.E.O.I. NO. 04/EE/AGRI/S/2020-21** as well as to whom and by whom offer is submitted.
2. The outer sealed cover in which the above two sealed covers are placed should be superscribed "for establishment of 1 unit Mushroom Spawn Production Centre at Office Complex of Deputy Director of Horticulture & Soil Conservation Udaipur, Gomati" and addressed to the Executive Engineer(South), Department of Agriculture & Farmers Welfare, Udaipur, Gomati .


8. **Earnest money will be 01 (One percent)% of quoted amount for each item or in clubbed as the case may be without ceiling limit** on any Nationalized bank having branch at Udaipur, Gomati guaranteed by the Reserve Bank of India should be deposited in the shape of **“Deposit at call” / “Demand Draft”** in favour of the Executive Engineer(South), Department of Agriculture & Farmers Welfare, Udaipur, Gomati having validity not less than 6 (Six) months. **The Earnest Money must be submitted along with the Technical Bid. 12. The supplied machineries/materials if not found up to satisfaction / standard or any other short coming shall have to be replaced by the supplier at their own cost and risk within 15(fifteen) days from the receipt of the intimation during the guarantee / warranty period.
