- 4. The EMD of the successful bidder will be kept as security deposit, which will be returned on completion of the Contract Term/Period whereas, for other bidders the same will be returned on completion of this Tender Process.

- d) ITC, PTC clearance certificate by the competent authority to be enclosed along with the Tender paper including Xerox copy of PAN Card.
- e) Experience certificate or documentary evidence towards effecting supply of Good quality wel rottrn cowdung manure to any Govt. institute /PSU/any agencies atleast last three years to be attached positively.
